

Principles of Public Administration & Democratic Governance (20:834:501) [3 credits]

Course Description

This course introduces students to the theoretical, intellectual, historical, institutional, and constitutional foundations of American public administration. We will explore the intersection between public administration theory and practice and examine many of the practical challenges currently affecting the American administrative state at all levels of government, including recent opinions of the Supreme Court of the United States.

Learning Objectives

After completing this course, students will be able to:

- Explain what public administration is and why it is critical to the practice of American government and the democratic governance process.
- Identify seminal scholars, theories, and some of the political, economic, and social dynamics associated with the historical evolution of the American administrative state.
- Apply theories of democratic governance to the practice of public management and running the American Constitution.
- Develop an understanding for how and how the American Constitution and the rule of law legitimate U.S. public administration in theory and practice.
- Improve writing quality, analytical thinking, and oral presentation skills.

Requirements

Requirements will vary by instructor and may include:

- · Assigned weekly readings from textbooks and other materials.
- Discussion of Supreme Court cases and their relevance to American public administration and democratic governance.
- · Group presentation of assigned materials.
- Final examination covering key concepts discussed throughout the course.
