DOCTORAL RESEARCH

My doctoral research analyzed Brazil's policymaking process, focusing on the LGBTQ movement's influence on anti-homophobia policies during the democratic period (1988-2021). Using process tracing, I particularly examined the movement's impact from 2001 to 2019, leading to the criminalization of LGBTphobia by the Supreme Federal Court decision in 2019. In-depth interviews were conducted with activists, politicians, and academics involved. The study identified LGBTQ movement strategies and the absence of legislative action, resulting in policy judicialization. A pattern of policy manipulation, "Potemkin Policy," was also observed from 1996 to 2021. The analysis concluded that ad hoc executive and judicial measures are implemented when the legislative branch fails. However, reliance on the judiciary may politicize policies and reduce long-term sustainability. Balancing short-term responses with lasting legislative solutions poses a challenge for LGBTQ+ policies in Brazil.
